

CBN releases \$3.5bn for foreign education under Buhari

Data obtained from the website of the Central Bank of Nigeria on Sunday revealed that Nigeria's educational sector suffered massive capital flight during the regime of the President, Major General Muhammadu Buhari(retd).

Specifically, using the CBN's balance of payment statistics, Nigerians have spent a hefty sum of \$3.5bn on foreign education in the past seven years (June 2015 to August 2022).

Naira redesign: CBN pledges to protect rural Nigerians

The Central Bank of Nigeria has pledged to protect Nigerians in the unbanked, underserved and rural areas as it plans to redesign the naira.

In a statement signed by the CBN's Director of Corporate Communications, Osita Nwanisobi, the apex bank said that it had been collaborating with relevant agencies and other stakeholders in the financial system to ensure that vulnerable citizens were not disenfranchised. The bank said that some progress had been as there had been increased currency deposits across banks and other financial institutions.

FG disburses N785m to 10m MSMEs

The Minister of Industry, Trade and Investment, Richard Adebayo, has said that the Federal Government, in its efforts to create the right environment for Micro, Small and Medium Enterprises to thrive, has disbursed N785 billion through the Bank of Industry to over 10 million MSMEs from 2019 to July 2022. He stated this on Thursday at the Command Guest House during the closing ceremony of the 14th Meeting of the National Council on Industry, Trade and Investment which had the theme, "Strengthening Industry, Trade and Investment Sector in Promoting Development in the Country." According to him, the intervention was made possible because the BOI further deepened its capital base to \$5 billion, attracting international partners like AFREXIM and Credit Suisse.

[Banks charge customers N715bn for electronic transactions, others](#)

Eleven banks charged their customers N714.61bn for electronic fees and other forms of commissions in the first nine months of 2022. According to the nine-month financial reports of the banks, this is a 16.92 per cent increase from the N611.21bn earned by the banks from the income source in the corresponding period of 2021. The banks included: Zenith Bank Plc, Sterling Bank Plc and Subsidiary, Stanbic IBTC Holdings Plc, Wema Bank Plc, Fidelity Bank Plc, and Union Bank of Nigeria Plc.

Two bank stocks – Access Bank and Sterling Bank Plc –drove activities in the financial service sector of the Nigerian Exchange Limited (NGX) last week. With the development, the financial sector maintained its dominance in volume terms with 859.019 million shares valued at N6.7 billion traded in 8,157 deals, contributing 78 per cent to the total equities turnover.

[Rising inflation drives consumption expenditure to N57tn](#)

Rising inflation drove Nigerians' consumption expenditure to N57.08tn in the first half of 2022. This is a 14.39 per cent increase from the N49.89tn that was spent in the corresponding period of 2021, according to the 'Nigerian Gross Domestic Product Report (Expenditure and Income Approach)' report by the National Bureau of Statistics. The NBS defined household final consumption expenditure as spending, including "imputed expenditure, incurred by resident households on individual consumption goods and services. This is calculated as a residual."

EU eyes 22m-ton annual gas import from Nigeria

European countries are making plans to ramp up gas importation from Nigeria to the tune of 22 million tons per year, providing an opportunity for Africa's most populous nation to earn revenues. A document obtained by The PUNCH from the Global Gas Monitor entitled, 'Europe Scrambles for African Gas', published by DW on Friday, said Africa was the next gas hub for European countries. The document put Nigeria as the country attracting the biggest European interest after Algeria (29 million tons).

Stock Market Down N164bn on Profit-taking in Guinness, Others

Trading activities in the stock market of the Nigerian Exchange Limited (NGX) took a negative turn last week as the loss recorded on the second trading day proved sufficient in wiping off the cumulative gain when the market closed on Friday. Precisely, the All-Share Index declined by 0.68 per cent week-on-week (WoW) to close at 43,968.75 basis points, driven by sell-offs in Guinness Nigeria, Flour Mills of Nigeria, Nigerian Breweries, MTN Nigeria Communications (MTNN) and Dangote Cement Plc. Similarly, market capitalisation shed N164billion Week-on-Week (WoW) to close at N23.949 trillion.

Knocks have trailed the loss of N116bn tax revenue by the state governments in Nigeria within a space of two years. According to the data from the Nigerian Bureau of Statistics, a total of 13 states had their tax revenue dipped by 27.5 per cent, from N423bn they recorded in 2019 to N306bn reported in 2021. The loss spanned across the six geopolitical zones. Enugu, Akwa Ibom, Bayelsa, Cross Rivers, Abia, Ogun, and Rivers were states from the southern part of Nigeria that recorded this revenue shortfall.

Flood affected 3.2million Nigerians, 1.4million displaced – UN

The United Nations has said the number of people affected by the flooding in Nigeria has risen to over 3.2 million, while over 1.4 million have been displaced. This is as the UN said the recent flooding that ravaged 34 states in the country was capable of increasing waterborne diseases in the affected states. It added that 4.1 million people are at risk of experiencing severe food insecurity, and 1.74 million children under 5 are projected to suffer from acute malnutrition in 2022.
