

CBN pledges inclusion of unbanked persons as cash deposit increases

The Central Bank of Nigeria (CBN) has lauded the increased deposit of cash in the banks and financial institutions across the country. The Director, Corporate Communications of CBN, Osita Nwanisobi, who stated this in Abuja at the weekend, also reiterated the bank's commitment to the seamless implementation of the initiative to ensure the achievement of its objectives to preserve the integrity of the local legal tender by reducing the significant amount of cash outside the banking system and its use in criminal activities, curtail counterfeiting, and promote financial inclusion, amongst others. Notwithstanding the progressive increase in financial access points and alternative banking channels over the years — electronic/internet banking, mobile apps, ATM, Cards/PoS, eNaira, agent banking, etc.) — the Bank acknowledges that these may not be evenly distributed across all geopolitical zones and in some rural areas.

President Muhammadu Buhari, yesterday, stated that the nation's revenue challenges are heightening the country's debt problem, necessitating the need to improve earnings as well as the ease of doing business. Buhari equally said it is true that what matters right now is the county's debt service to revenue ratio which is undoubtedly high but admitted that increasing revenues should henceforth engage most of the government's attention. The President however assured that the country is already witnessing real improvements from the non-oil revenues, warning that the government must now focus more on productivity and encourage value addition.

Nigeria can't survive with endless borrowing - DMO

The Debt Management Office has disclosed that it has been difficult for Nigeria to borrow from the international markets as global lenders and investors are shunning countries with Category 'B' economic ratings. According to the Director-General of the DMO, Patience Oniha, Nigeria must gear up its revenue drive while looking for alternative sources of funds internationally. "We really can't survive like this," she stated. Oniha, while appearing before the House of Representatives Committee on Aids, Loans and Debt Management to defend the DMO's 2023 budget, noted that the Federal Government had not been able to meet its external borrowing target, noting that it was now looking at lenders in the United States and Europe. She said, "Where there is an issue is the new external borrowings.

Rising inflation drives consumption expenditure to N57tn

Rising inflation drove Nigerians' consumption expenditure to N57.08tn in the first half of 2022. This is a 14.39 per cent increase from the N49.89tn that was spent in the corresponding period of 2021, according to the 'Nigerian Gross Domestic Product Report (Expenditure and Income Approach)' report by the National Bureau of Statistics. The NBS defined household final consumption expenditure as spending, including "imputed expenditure, incurred by resident households on individual consumption goods and services. This is calculated as a residual." The agency further disclosed that household final consumption grew by 6.94 per cent and 17.64 per cent in Q1 and Q2 2022 respectively, on a year-on-year basis, in real terms.

Investors dump shares in exchange's alternative board

Following their weak corporate earnings, investors have shunned listed companies on the Nigerian Exchange Limited's Alternative Securities Market Board. A total of four companies comprising Capital Oil Plc, Rak Unity Petroleum Company Plc, Juli Plc, and Smart Products Nigeria Plc are listed on the ASeM with severe economic headwinds playing a critical impact on earnings of the companies on the Board declared on the NGX. The ASeM is a specialised board for emerging businesses: small and mid-sized companies with high growth potential seeking to access the capital market. In the 10 months of 2022, the stock price of three companies on the ASeM board traded flat while Juli Plc's stock price depreciated.

Nigerian banks' assets rise by N10tn, hit N66tn

Nigerian banks' assets gained N10th between August 2021 and August 2022 to hit N66.76th, latest figures from the Central Bank of Nigeria has revealed. The CBN disclosed in the personal statement of a member of the Monetary Policy Committee, Kingsley Obiora, that the banking sector remained resilient amid economic challenges. It stated, "Despite these headwinds, the banking system remained sound, safe and resilient amid slowing economic growth. Total assets of the banking industry showed an increase of N10.72th or 19.13 per cent from N56.04th per cent in August 2021 to N66.76th in August 2022, driven by balances with CBN/banks, investments, and credit expansion to the real sector.

Tax net expansion vital for health sector growth - AIICO MD

It is said that Sub-Saharan Africa bears 40 per cent of the global health burden and Nigeria represents approximately one-quarter of Sub-Saharan Africa; in effect, Nigeria bears about 10 per cent of the global health burden, which means if you add up all the illnesses worldwide, 10 per cent of them reside in Nigeria, and that is a huge number considering that the population of Nigeria is about 2.5 per cent of the population of the world. That gives you an idea of the kind of disease burden we are carrying. We define health as being not just the absence of infirmity but the complete state of mental, physical, and social well-being. We have a huge health challenge, but we do not have the resources to meet the challenge. Even without our nurses, doctors, and pharmacists travelling abroad, we had a manpower deficit.

FIFA appeals for World Cup ceasefire in Ukraine

The president of the world football body called Tuesday for a one-month ceasefire in Ukraine to mark the World Cup, saying sport could bring people together. FIFA president Gianni Infantino, addressing leaders of the Group of 20 major economies gathered in Bali, said the World Cup opening Sunday in Qatar could serve as a "positive trigger" in the nearly nine-month Russian invasion of Ukraine. "My plea to all of you is to think of a temporary ceasefire for one month for the duration of the World Cup," he told a G20 lunch for the leaders. If not a full ceasefire, there can be "the implementation of some humanitarian corridors or anything that could lead to the resumption of dialogue," he said.

Djokovic to get visa for 2023 Australian Open

Former world number one Novak Djokovic will be granted a visa to play in the 2023 Australian Open, local media reports said Tuesday, despite his deportation from the country ahead of this year's tournament in January. 237-day medical trips: Despite Buhari's pledge to cut cost, presidential fleet racks up N64.15b

President Muhammadu Buhari returned to the country on Sunday night, marking his 10th medical return trips from London, and 237 days of either treating or checking undisclosed ailments abroad in the last seven years. President Buhari's medical tourism record, which is unprecedented in Nigeria's history, as well, costs the country in medical bills and operating cost of the Nigerian Air Force One (NAF 001) airplane. The Guardian estimate showed that the trips already cost between N1.1 billion to N5.4 billion in sundry operational costs, including fuel, landing and parking charges. Read More+

Oil theft: FG arraigns 16 foreigners, detains vessel

A Federal High Court sitting in Port Harcourt, Rivers State, has arraigned 16 foreigners for offences bordering on conspiracy, stealing, attempt to deal in crude oil and false pretences. The foreign nationals were caught onboard a vessel, MT Heroic Idun. According to the charges, the foreigners had, in August 2022, at the Akpo Oilfield in Rivers State, conspired among themselves and committed maritime offences.
